In 2018, Wild Virginia continued working to protect our public lands through advocacy, education, and influence. Along with our partners and alliances, we pressed on in the fight against the Mountain Valley and Atlantic Coast fracked gas pipelines. Both of these pipelines pose great risks to the water quality, connectivity, biodiversity, and resilience of our forests and surrounding communities. Stopping the construction of these pipelines would maintain intact forests and protect our region's water supply. Wild Virginia is working to stop these projects by bringing regulatory and legal challenges and mobilizing citizens like you to monitor and report environmental destruction created by construction activities. We're also working to improve habitat connectivity throughout the entire Commonwealth and to ensure that our waterways are granted all the regulatory protections they deserve.

We also want to help you experience Virginia's wild places and learn how to help protect them. Throughout the year, we offer a wide variety of ways to do just that. If you prefer to get outside, you can join our camping, hiking and paddling trips. For indoor activities, we offer the Wild and Scenic Film Festival, comment writing nights, classes, lectures, and book clubs. Advocacy for Water Protection

The Wild and Scenic Rivers Act, passed by Congress 50 years ago, provides for recognition of especially notable streams and gives them enhanced levels of protection. Virginia has so far failed to have any Wild and Scenic Rivers named. and we intend to fix that. We are organizing an effort with other Virginiabased water advocates to provide extra water quality protections through federal and state programs where special designations can be acquired. 
Wild & Scenic Film Festival

Battles Against the Pipeline


Habitat Connectivity

Wild Virginia has helped to create and lead a broad coalition of groups called the Virginia Safe Wildlife Corridors Collaborative. The aim of the collaborative is not only to reduce wildlife-vehicle conflicts. but also to work towards implementing measures, like wildlife crossings, that allow the safe movement of wildlife across roads. We are also working on larger initiatives to identify animal/vehicle crash hotspots and to improve habitat connectivity for wildlife throughout Virginia. Advocacy for Water Protection

The National Wild and Scenic Rivers System was created by Congress "... to preserve certain rivers with outstanding natural, cultural, and recreational values in a free-flowing condition for the enjoyment of present and future generations. The Act is notable for safeguarding the special character of these rivers, while also recognizing the potential for their appropriate use and development. It encourages river management that crosses political boundaries and promotes public participation in developing goals for river protection."

Virginia has so far failed to have any Wild and Scenic Rivers named, and Wild Virginia is working to fix that problem. We are organizing an effort with other Virginia water advocates to provide extra water quality protections through federal and state programs where special designations can be acquired.



Battle Against the Pipeline

The Atlantic Coast Pipeline (ACP) is a proposed 600-mile long natural gas pipeline to carry natural gas from West Virginia through Virginia to North Carolina. The Mountain Valley Pipeline (MVP) sources the same fracked gas and has the same delivery destinations as the ACP. The pipelines directly threaten local drinking water, homes, endangered species' habitats, parks, economies and other vital interconnected systems and attributes of the Southeast. They simply cannot be safely built. Both companies have begun permitted tree felling. In March 2018, the Virginia Department of Environmental Quality approved the MVP's additional plans, and construction has now begun.

While we could only get three of the seven Water Board members to support revocation of the state approvals earlier in 2018, we didn't stop making the case and, in an unprecedented move, the Board voted to start the revocation process for MVP at the end of the year. Wild Virginia also joined numerous lawsuits when federal and state regulators failed to do their jobs on both MVP and ACP. Earlier in 2018, the 4th Circuit Court of Appeals knocked down the Forest Service permit for MVP and did the same for ACP on December 13. Other cases and new administrative processes forced by our actions are yet to be decided, and we'll be there fighting at every step.



Habitat Connectivity



Habitat connectivity, in the form of large cores of intact habitat and corridors connecting them, is critical to ensuring a sustainable future for Virginia. Wild Virginia has been leading the way, bringing people to work together to improve habitat connectivity throughout Virginia.

Wild Virginia is the driving force behind the multidisciplinary, multi-agency group called the Virginia Safe Wildlife Corridors Collaborative (VSWCC). The organization believes in taking a multiple stakeholder approach to solving complex transportation and ecological problems along Virginia roads. The VSWCC aims to reduce habitat fragmentation issues and improve habitat connectivity in the state. Its partners work together to identify and implement innovative solutions to address human safety, wildlife conservation, and habitat connectivity concerns. Through the VSWCC, Wild Virginia is working to protect people and wildlife and reducing animal-vehicle conflicts and improving safe wildlife passage.

We recognize Wild Virginia's unique role as an advocacy organization and a leader in the collaborative, so we will work to keep the group focused on larger habitat connectivity concerns while working on the specific fragmentation impacts of roads.
