Jessica Roberts has over 10 years of experience in wildlife research and recovery, advocacy, and community-based conservation initiatives. After graduating with a bachelor's degree in environmental studies from American University, she began her career working with AmeriCorps as the Watershed Restoration Coordinator for a conservation nonprofit in California. There, she created and supervised watershed restoration and education programs in connection with California State Parks. Jessica was inspired to pursue a graduate degree after working in wildlife conservation at the Wildlife Center of Virginia and as the Red-Browed Amazon Recovery Program lead at ZooTampa. While reinforcing her skills in wildlife population management, captive-breeding, and species reintroduction, she noticed a gap in the research on captive management techniques for improved reintroduction success. Jessica helped fill that gap while earning her PhD at George Mason University in the Department of Environmental Science and Policy by providing more evidence-based information to conservationists for improving endangered species reintroduction programs. Jessica is passionate about wildlife recovery and excited to join the team at Wild Virginia advancing habitat connectivity programs and connecting with more communities in the state she calls home.

IMPROVING HABITAT CONNECTIVITY

We continued to advance significant intiatives in 2023. Here's a look at our key leadership moments!

We welcomed our new **Habitat Connectivity Director**, Dr. Jessica Roberts, to the Wild Virginia team! Jessica has over 10 years of experience in wildlife research and recovery, advocacy, and community-based conservation initiatives.

Wild Virginia continued to co-lead the <u>Virginia Safe Wildlife Corridors Collaborative</u>, a group that is committed to protecting people and wildlife by reducing animal-vehicle conflicts and improving safe wildlife passage.

WILLIAM & MARY SOLAR & HABITAT CONNECTIVITY PROJECT

In 2023, Wild Virginia partnered with William & Mary to mentor students Marley Fishburn and Hannah Roverse on their solar siting and habitat connectivity research.

Their research addressed the rising rate of solar farms and the problems they can pose for the conservation of wild areas and key wildlife corridors.

Through our partnership, the students were able to create a tool that could be used to help plan solar sites that maximize production while minimizing damage to wildlife habitats.

Preventing PFAS Pollution

Wild Virginia's newest campaign!

In September 2023, Wild Virginia announced its newest campaign to stop releases of the forever chemicals Per- and Polyfluoroalkyl Substances (PFAS) to the environment! These toxic, synthetic chemicals are present throughout Virginia in the air, water, and soil and threaten our enjoyment of Virginia's wild places, the health of our communities, and the health of wildlife. Wild Virginia aims to prevent further PFAS contamination by stopping PFAS pollution at its source through:

- Holding state agencies accountable. PFAS are being dumped into our rivers and streams.
- Advocating for state legislation that will reduce PFAS pollution, lessen current contamination, notify the public of any future contamination, and compensate landowners for pollution damages.
- Mandating testing and removal of PFAS from sewage sludge biosolids before they can be spread on farmland.
- Educating Virginians, like you, about PFAS and what you can do to help we even hosted our first virtual town hall meeting in October to educate the public on this important issue!

Wild Virginia got straight to work with the campaign and joined Southern Environmental Law Center, the James River Association, Blue Ridge Environmental Defense League and others in submitting public comments on state discharge permits throughout Virginia. We have also targeted several permits in Roanoke, Scottsville, and Hampton Roads for intensive attention and advocacy to involve more people and anticipate official public comment opportunities in 2024.

PFAS are being discovered in waters across Virginia and gaining public attention. In 2024, you can rely on Wild Virginia to continue to be a leading force in preventing further contamination.



PROTECTING WATER QUALITY



Clean Water Advocates

We graduated our **first class of Clean Water Advocates**, our statewide program that trains volunteers to work beside us and bolster our effectiveness in agency regulatory proceedings. Advocates were provided with knowledge of federal and state water protection laws, regulatory processes, and basic advocacy skills to influence environmental decisions and outcomes. Advocate graduate Carolyn Schuyler says that:

"THIS PROGRAM IS REALLY GREAT BECAUSE IT'S CASTING THE NET BROADER, AND ALLOWING PEOPLE THAT WANT TO HELP TO LEARN FROM THE EXPERTISE OF THE PEOPLE THAT HAVE BEEN DOING THIS SO EFFECTIVELY AT WILD VIRGINIA."

Advocates support Wild Virginia's efforts to protect Virginia's water quality! We look forward to training another cohort of Clean Water advocates in 2024.





PIPELINE OPPOSITION

In June 2023, the U.S. Congress passed the Fiscal Responsibility Act which forced all final federal agency approvals for completion of the Mountain Valley Pipeline. Wild Virginia quickly adjusted our approach to focus on preventing further environmental harms and reducing risks caused by construction of the pipeline. This was a major disappointment, but the passage of the Fiscal Responsibility Act shows how powerful pipeline opponents were in regulatory and court proceedings, because MVP supporters needed to take unprecedented action and change the rules to push the project forward.

We did not and **will not stop pushing for accountability** from the builders and especially from those state and federal officials who are supposed to protect you and your interests.

- Each week, we convene a broad-based strategy group to make sure that all allies have the most upto-date information so that we can take effective action.
- We work with volunteer monitors who are in the field documenting violations and damage.
- We acquire and review a mass of information from state agencies that shows water quality threats and damages—information the agencies have only released when we demanded it under the law.

Habitat Connectivity Director, Jessica Roberts, was interviewed by WVTF, speaking about the importance of fencing for safe wildlife passage:

ALONG 16 WEST OF CHARLOTTESVILLE,
AND THEY PUT UP THIS FENCING TO
DIRECT ANIMALS INTO TWO EXISTING
UNDERPASSES. IT REDUCED VEHICLE
CRASHES AROUND 90 PERCENT, AND IT
ALSO INCREASED WILDLIFE USE OF
THOSE CULVERTS BY FOUR HUNDRED
PERCENT IN SOME AREAS."
